 4. Section B must be completed and signed by the former owner(s) (and all joint owners, if any) listed on the face of this document. In the case of a Deceased Estate the form MUST be signed by the Executor/s (attach copy of letter of Executorship). (Signatures are mandatory for the processing of transfers). If applicant is a minor (under 18) – the legal guardian must sign on behalf of the minor and a copy of the legal guardian's Identity Document must be attached.  
 5. Section C must be completed and signed by the new owner(s) (and all joint owners, if any). (Signatures are mandatory)  
 6. The original document submitted as the application for registration of a transfer will be retained and will remain the property of the Kennel Union of Southern Africa. A new certificate reflecting the change of ownership, will be issued.
